IS KING KONG PROTECTED BY THE ENDANGERED SPECIES ACT?

LAWYERS IN THE MIST

A species is "endangered" if it is "in danger of extinction throughout all or a significant portion of its range." 16 U.S. CODE § 1532(6).

A species is "threatened" if it is "likely to become an endangered species within the foreseeable future throughout all or a significant portion of its range." Id. § 1532(20); Conservation Force, Inc. v. Jewell, 733 F.3d 1200, 1202 (D.C. Cir. 2013).

A species is considered "endangered" because of "natural or manmade factors affecting its continued existence." 16 USCS § 1533(a)(1)(E).

2005 – The White House Still Does Not Believe that Kong Needs Protection...




1976 – Clearly, the Passage of the Environmental Species Act Did Not Help ...

THE DUTY TO RESCUE

No general common law duty to rescue someone unless there is a special relationship.

Rhodes v. Illinois Cent. Gulf R.R., 172 III. 2d 213, 232-233 (III. 1996).

A duty to rescue can be created between individuals by

1) Statutes;

2) Contractual relationships; or

3) Impliedly by virtue of the relationship between the tortfeasor and a third party.

Bobo v. State, 346 Md. 706, 715, 697 A.2d 1371 (1997).

WHAT IS CARL DENHAM LIABILITY FOR KING KONG'S RAMPAGE ACROSS NEW YORK?

"One who keeps wild animals on his premises must see to it at his peril that they do no damage to others."

Hyde v. Utica, 20 N.Y.S.2d 335, 337 (App. Div. 1940)

"[A] wild animal is presumed to be vicious and since the owner of such animal...is an insurer against the acts of the animal to anyone who is injured..."

Baugh v. Beatty, 91 Cal. App. 2d 786, 791, 205 P.2d 671 (1949) (case involving an attack by a chimpanzee)

Wild Animals include primates.

New York Consolidated Laws, General Municipal Law - GMU § 209-cc(2)(c)(1).

ARTICLE V OF THE TREATY OF MUTUAL COOPERATION AND SECURITY BETWEEN THE UNITED STATES AND JAPAN

Each Party recognizes that an armed attack against either Party in the territories under the administration of Japan would be dangerous to its own peace and safety and declares that it would act to meet the common danger in accordance with its constitutional provisions and processes.



U.S. ENVIRONMENTAL LAWS ARE RELAXED FOR OVERSEAS U.S. MILITARY BASES Executive Order 12114 (Jan. 4, 1979), 44 FR 1957, 3 CFR, 1979 Comp.,

p. 356:

"If a major Federal action having effects on the environment of the United States or the global commons requires preparation of an environmental impact statement, and if the action also has effects on the environment of a foreign nation, an environmental impact statement need not be prepared with respect to the effects on the environment of the foreign nation."

U.S. ENVIRONMENTAL LAWS ARE RELAXED FOR OVERSEAS U.S. MILITARY BASES

Agreement to Supplement the Japan-U.S. Status of Forces Agreement (SOFA) on Environmental Stewardship (2015)

Provides that the Japanese government or local municipalities "may request" permission from the U.S. to conduct environmental surveys in the event of environmental incidents at U.S. military bases in Japan.

The U.S. will "give all due consideration to the request" and "respond as promptly as practicable."

Japan "may also request to take samples" in relation to on-the-spot surveys

BUT, there is no requirement that the U.S. agree to the surveys

NOT SURPRISINGLY, IN "THE HOST" THE U.S. GOVERNMENT IS NOT HELD LIABLE FOR CREATING THE MONSTER, OR USING "AGENT YELLOW" AGAINST IT





JAPANESE LAW MAY MAKE SOME POLLUTERS LIABLE FOR CREATING HEDORAH AND GODZILLA

AIR POLLUTION CONTROL ACT

Regulates smoke and soot, as well as dust from factories and business establishments

Implements countermeasures for hazardous air pollutants

Provides liability in damages to protect victims from business establishments.


ACT ON COMPENSATION FOR NUCLEAR DAMAGE

"The purpose of this Act is to protect persons from nuclear damage and to contribute to the sound development of the nuclear industry by establishing the basic system regarding compensation in case of a nuclear damage caused by reactor operation, etc."

OFFENSIVE ODOR CONTROL LAW

Protects Japanese nation's health by regulating offensive odors from factories in regulated areas
